This review process may allow us to provide additional loans or work-study funds to help you provide for food and shelter expenses when available family income is insufficient to provide both educational and dependent-related expenses. Federal regulations prohibit including expenses for other adults in the household.

This procedure also requires that your federal aid application (FAFSA) first be verified with your federal tax return, W2s and other verification forms, if your 2011-2012 FAFSA has not yet been verified. If your spouse is also a Boise State student, his/her financial aid file will also be verified using the documentation you provide. **Disbursement of aid will be held until verification is complete. Be aware, the verification process could result in a higher EFC which may require you to pay back some Pell grant money and would disqualify you from receiving this increase.**
