Most unmarried undergraduates under the age of 24 are considered **dependent** for federal financial aid purposes and therefore must provide parental information on the FAFSA. If your parents have ended all financial support **or** refuse to provide their information on your FAFSA, then you may submit this petition to receive **only unsubsidized loans**.

Pros and Cons to Submitting a FAFSA without Parent Income Information

- Pros: A federal unsubsidized loan is better than alternative/private education loans and credit cards. Some federal aid is better than no federal aid. Federal student loans do not involve checking a student's credit rating.
- Cons: Only an unsubsidized loan can be awarded. You will be ineligible for Pell Grant, SEOG Grant, need-based scholarships, work-study, federal subsidized loans, and Parent PLUS Loans. The amount of unsubsidized loan is limited to the annual grade level limit for dependent students (freshman \$5,500; sophomore \$6,500; junior/senior \$7,500).
